All exhibits, ASSA Registration and sessions will be located in the Walter E. Washington Convention Center. Exhibits and ASSA Registration will be in Exhibit Hall A on the concourse level of the Walter E. Washington Convention Center with the enclosed floor plan. The exhibit area will be available to exhibitors for registration and setup from 12pm – 6pm on January 1st and 7am – 1pm on January 2nd. Dismantling will be from 1pm – 5pm on Tuesday, January 5th. Badges are required in the exhibit area at all times. Each booth gets up to four complimentary Exhibitor Badges. If more than four are needed, they will need to register as a regular attendee. Exhibitors will not relocate their assigned booth within Exhibit Hall A once onsite without authorization from Paityn Connolly, Assistant Convention Manager. ***Coffee will be available to exhibitors and attendees each morning and afternoon. The AEA Headshot Booth will be available to attendees in the exhibit hall again this year.***
