### 1 Selection Model

The full selection model is given below. Given that we only focus on one origin sector (manufacturing), we omit the  $o$  subscripts for simplicity. The number of potential destination sectors is 9.

$$\begin{aligned} \Delta \ln wage_{id} &= X'_i \beta_d + \Delta K'_i \gamma + \epsilon_{id} \\ V_{id} &= X'_i \tilde{\beta}_d + \Delta K'_i \tilde{\gamma} + \sum_{s=1}^9 \gamma_d^s CN_{is} + \eta_{id} \quad (d = 1, \dots, 9) \\ D_{id} &= \begin{cases} 1 & \iff V_{id} = \max(V_{i1}, \dots, V_{i9}) \\ 0 & otherwise \end{cases} \end{aligned} \quad (1)$$

$\Delta \ln wage_{id}$  represents the log change in wages for worker  $i$  moving from manufacturing to destination sector  $d$ .  $V_{id}$  represents the utility worker  $i$  obtains in sector  $d$ , which is determined by pecuniary and non-pecuniary factors. The latter include our coworker selection instruments  $CN_{is}$  (the number of worker  $i$ 's past coworkers present in sector  $s$  at the time of worker  $i$ 's displacement). Workers sort into the sector that maximizes their utility  $V_{id}$ .

We assume the error terms in the selection equation ( $\eta_{id}$ ) are i.i.d extreme value type I. Furthermore, we impose the following linearity assumption on the structure of the error terms:

$$E[\epsilon_{id} | \eta_{i1} \dots \eta_{i9}] = \sigma \frac{\sqrt{6}}{\pi} \sum_s r_d^s (\eta_{is} - E[\eta_{is}])$$

These assumptions are based on work by Dubin and McFadden (1984) and described in detail in Bourguignon et al. (2007), and allow us to write the outcome equation in the following manner:

$$\Delta \ln wage_{id} = X'_i \beta_d + \Delta K'_i \gamma + \lambda_d(p_{i1}, \dots, p_{i9}) + \omega_{id}$$

where  $\lambda_d(\bullet)$  represents the selection correction function with the probabilities  $p_{is}$ 's (that indi-

vidual  $i$  from moves to sector  $s$ ) as arguments. Dubin and McFadden (1984) show that under our assumptions this correction function takes the form:

$$\lambda_d(\bullet) = \sigma \frac{\sqrt{6}}{\pi} \left[ \sum_{s \neq d} r_d^s \left( \frac{p_{is} \ln p_{is}}{1 - p_{is}} \right) - r_d^d \ln p_{id} \right]$$

## 3 First Stage Results

The first stage estimates are presented in Table A.2. Each column represents a potential destination sector  $d$ . Each cell contains the estimated coefficient  $\gamma_d^s$  for  $CN_{is}$  (the number of coworkers

with jobs in sector  $s$  at the time of worker  $i$ 's switch). Hence, the entries on the diagonal indicate that having coworkers in sector  $d$  increases the probability that worker  $i$  moves to  $d$ .
