NSF, Census and BEA receive FY2012 budget allocations

The FY2012 minibus (instead of omnibus) \$182 billion appropriation bill that passed Congress in November includes budgets for National Science Foundation (NSF), the US Bureau of Census and the Bureau of Economic Analysis (BEA). The bill also extended the Continuing Resolution covering the remainder of government operations through December 16th. This extension covers pending appropriations for the National Institutes of Health (NIH) and the Bureau of Labor Statistics (BLS).

The NSF budget allocation for FY2012 was \$7,033,095,000 up \$173,320,000 over FY2011. The Census budget for FY2012 of \$943 million was less than its \$1.05 billion FY2011 level. BEA's budget allocation of \$92.2 million was less than the FY2011 level of \$93.4 million.
