- Sexual orientation: One's innate sense of attraction to men, women, both, neither

- <u>Gender identity</u>: One's innate sense of feeling male, female, both, or neither
  - E.g.: cisgender, transgender, non-binary, NB






# Particularly among youths

# Geographic distribution


Same-sex couples per 1,000 households by county (adjusted)\*
