Dear Fellow-economist,

This Newsletter will be primarily devoted to listing openings- not only for jobs but for non-employment professional activities. Do share them with other women economists; our roster now numbers 1300 but is still growing. We've not yet "found" nearly enough of you in business and government, so please help. Write Betsy Munzer for as many registration forms as you can use. We have enclosed a registration form for those of you about whom we know only your address.

The Committee's "findings, recommendations, and conclusions" will be published in the December, 1973 issue of the American Economic Review; reprints will be available early in 1974 (write Betsy Munzer). We cannot supply these at zero price because our cost has been substantial, so please send \$2.50 for each reprint you order. The session discussing this article should prove lively: Professor George Stigler of the University of Chicago, Professor David Gordon of the New School, and Professor Elizabeth Clayton of the University of Missouri will form a panel of critics but we hope for much comment from the floor. If you can't come Friday, December 28th at 2:30 PM send a friend and help us get publicity for the first substantive treatment of discrimination as an economic phenomenon. At the Hilton there will be a suite for the Committee to welcome women economists and employers. We will provide registration, information and the exchange of all sorts of ideas, so do stop by between 8:30 A.M. to 6:00 P.M..

Two new policies you should know about. At our November meeting we agreed to an experiment in answering the many, many requests for names that come to us constantly. As always, we will give full publicity to all openings via this Newsletter, but we shall also send prospective employers listing specific fields the names of women registered with us who have given these fields as their specialties. A covering letter explains that ONLY names and addresses are provided, that we have no way of knowing whether or not these people are available and if so on what terms, and that employers should ask for other suggestions when they write to the women named. We thought long and hard about this experiment and we are not entirely happy. On the one hand we know our roster is not complete, and we have no real expertise in carrying out an employment agency function. On the other hand, if we do not provide some positive information to employers, we run the risk of losing credibility. Finally, if other people are willing to provide names from the limited number of women economists they know, then the larger group will suffer. We remain convinced, however, that the primary aim of all these efforts should be to widen the market, and the information network.

The second policy has to do with publicizing economic research and writings by women. We hope in future Newsletters to list significant articles and books written

by women economists so that newly published authors can benefit from word-of-mouth advertising. But we would also like to acquaint the profession with the wide expertise of women economists, and to this end we want to begin to compile a bibliography of such writings.

Federation of Organizations for Professional Women: Dr. Barbara Newell, President of Wellesley College, in Wellesley, Massachusetts, addressed the delegates at the meeting of the Governing Board regarding a joint effort by the Federation and the College for the establishment of a women's center at Wellesley College. The college recently acquired a thirty-two room estate adjacent to the campus which Dr. Newell would like to develop into a national center for research and development on women.

The center is to serve as an institutional setting for broad projects investigating the problems of women in higher education, their needs, barriers to access and advancement, women's studies, factors influencing career choice, etc. A training center could be established to deal with the requirements of women who have been out of the market place for some years, as well as for those women who need particular skills in management techniques, quantitative methods, etc. Third, the center could serve as a focus for research on the role of women in society -- in scholarly fields such as science, or in the arts and humanities, for example. Individual scholars would be encouraged to become residential scholars at Wellesley House to undertake research related to women, and women scholars at all levels would be encouraged to use Wellesley House as an institutional base to carry out their individual research efforts in all fields of endeavor. Seminar and cooperative arrangements would be developed with Wellesley College students and faculty to serve as role models for women students in a variety of fields.

The Federation is exploring the feasibility of moving its headquarters to Wellesley House and becoming the administrative arm of this kind of research center. A proposal for funding is currently being developed by a small group chaired by Martha Blaxall, the Committee on the Status of Women in the Economics Profession of the American Economic Association. Other members of the group include Betty Bone, International Association of Personnel Women; Beatrice Bain, Women's Center, U. of California, Berkeley; Betsy Munzer, AEA Committee; and Leslie Wolfe, Civil Rights Commission. The group is actively soliciting ideas and information on specific projects and women to be incorporated into the proposal. Women's Equity Action League: The Committee urges everyone to support, preferably by joining at your local level, the Women's Equity Action League, otherwise known as WEAL. The organization will begin action on some of the economic problems of women, including credit availability and tax discrimination, and cooperation from economists will be useful.

Ad Hoc Hiring Practices Committee: One of the items mentioned in the forthcoming report from the Hiring Practices Committee chaired by Ray Marshall of the University of Texas, is the generally high success rate of "blind" letters of application when job openings are being filled. Keep this in mind when you look over the job list included and watch for the H.P.C. report.

Organization Renewal, Inc.: There will be a conference on The Emerging Woman in Management on January 9-11 in Chicago and one January 15-17 in Washington, DC for those interested.
