Janice Madden and Margaret Simms will rotate off the Committee after completing three year terms. We are indebted to both for their many valuable contributions to CSWEP. Among other things, Janice has been in charge of the roster while Margaret has served as informal rapporteur for Committee meetings and has been particularly helpful

in developing regional activities. Responsibility for the roster will be taken over by Marianne Ferber.

The first order of business at the August 28 meeting was the Equal Rights Amendment and the progress of efforts to move the site of the 1979 ASSA meetings from Atlanta to a ratified state. The Committee discussed a resolution on the subject that was proposed for discussion at the upcoming AEA business meeting by Paul Samuelson and seconded by Jere Behrman. The resolution was designed to allow the members of the Association an opportunity to vote on the issue of moving the 1979 meetings. The resolution itself requests that the meetings be moved, but because of the fact that less than one per cent of the membership would be voting at the business meeting, passage of the resolution would not result in an automatic decision to move the meetings. Rather, passage would result in a poll of the entire membership by mail. Committee members were urged to get the word around about the importance of attending the business meeting.

Next on the agenda at the August 28 meeting was a discussion of plans for participation in regional association meetings. Joan Haworth, serving as representative for the Southern region, has arranged CSWEP activities at the Southern Economic Association annual meeting, November 8-10, 1978, in Washington, D.C. These include a CSWEP sponsored session on "Inadequate Public Data for Policy Needs," a CSWEP Southern regional business meeting and a wine and cheese party. Marianne Ferber has formed a panel for the Midwestern meetings, scheduled for Spring 1979, on the "Economic Status of Women in Different Economies." Ann Friedlaender has made arrangements for Carol Greenwald to chair a session on "State Regulation and Banking Policy," at the Eastern meetings, also scheduled for Spring 1979. There are no plans as yet for the Western meetings, which come somewhat later.

The Committee would like to hear from members who would be willing to serve as regional representatives. The responsibilities of the representative would be to help organize sessions, open business meetings and other regional activities and serve as liaison with CSWEP. The Association cannot provide financial support for regional representatives of CSWEP, but we hope that representatives attending the annual ASSA meetings will be able to join the Committee in a dinner and business meeting. We cannot offer transportation, however. If you are interested, let Ann Friedlaender know.

During the annual meetings in Chicago, CSWEP had a hospitality room for women economists and other visitors. As in previous years, coffee was provided and a listing of current job opportunities was posted for those interested. Also posted was information about the Samuelson-Behrman resolution and the agenda for the impending business meeting of the AEA.

The CSWEP open meeting was well attended. Ann Friedlaender presided. Current and past members of the Committee were introduced. Also introduced were the two new members. The Committee then reported on the following activities: (1) Ann Friedlaender reported on efforts to move the annual

meetings of the Association from non-ERA states. She explained the upcoming resolution and stressed the importance of attending the annual business meeting. (2) Ann summarized CSWEP's regional activities and invited volunteers to serve as regional representatives. (3) Ann reported on the current status of women in the profession. This included the percentage of economics degrees received by women, the percentage of faculty slots held by women, and the distribution of new hires. Earlier in the day, she had presented her findings at the breakfast meeting of Department Chairpersons. Her report will appear in the Proceedings issue of the AER in May. (4) Mariam Chamberlain reported on the newsletter and invited suggestions about items to include. (5) Janice Madden reported on roster operations. (6) Marianne Ferber reported on the CSWEP Research Survey, which may have to be abandoned for lack of sufficient response. The remainder of the meeting was devoted to the ERA and possible actions to take with regard to the 1979 meetings.

Rounding out CSWEP-sponsored activities at the Chicago meeting was the program session on Equity: The Individual vs. the Family. As noted in the previous Newsletter, the three papers presented for discussion will be published in the next Papers and Proceedings issue of the AER.

At the annual business meeting of the Association, notwithstanding the efforts of the Committee and its friends, the Samuelson-Behrman resolution failed to pass by a single vote. We won't go into details here since those will be provided in the official minutes of the meeting that will be included in the next issue of the Proceedings. Suffice it to say that the 1979 meeting will be held in Atlanta.

The theme of the CSWEP sponsored session in the 1979 program is: "Consequences of the Growth of the Two-Earner Family." This topic may include but is not limited to questions having to do with distributional implications, demographic changes, impact on demand, influence on family formation, marriage, etc. If you are working on any aspects of this topic and would like to present a paper, please send an abstract or a copy of the proposed paper by February 1 to: Ann Friedlaender, Department of Economics, Massachusetts Institute of Technology, Cambridge, Massachusetts 02139.

NEWS FROM WASHINGTON

The big news from Washington is the appointment of former CSWEP member Nancy Teeters to the Federal Reserve Board of Governors. She was nominated for the position by President Carter and confirmed by the Senate in September. She is the first woman to serve in that capacity.

Women's access to housing credit is the subject of a new two-year program at the U.S. Department of Housing and Urban Development (HUD) under the title Project on Women and Credit. The project has three goals: (1) to inform women of their rights under the fair housing and equal credit laws, (2) to educate women about the mortgage market and thereby facilitate informed decisions about

housing and credit needs, and (3) to study the extent and nature of sex discrimination in mortgage lending to assist regulatory agencies and private litigants in enforcement of equal credit laws. The Project Director is Susan Ness.

CONFERENCES

A national conference of women's committees and caucuses in the humanities and social sciences was held at the National Archives in Washington, D. C. on October 24-25. CSWEP was one of the 46 groups invited to participate and Mariam Chamberlain served as delegate. The conference was funded by the National Endowment for the Humanities and organized under the auspices of the Organization of American Historians. The principal speakers included Mary Berry, Assistant Secretary for Education at HEW and Joseph Duffey, Chairman of the National Endowment for the Humanities. The purpose of the conference was to exchange information on the status of women in the various academic fields; review efforts to further the equality of women in each field; identify pressing problems that require research; and develop a standardized statistical reporting form in which to organize and present information on the changing status of academic women. At the close of the conference the group formed a Coalition for Women in the Humanities and Social Sciences, an informal network for further communication and follow-up activity.

The National Women's Studies Association will hold its First National Conference at the University of Kansas at Lawrence May 30 - June 3, 1979. The Conference Committee invites participation and proposals for panels, papers, seminars or workshops. The Conference Coordinators are Emily Abel and Peg Strobel of the Women's Studies Program, California State University at Long Beach.

OTHER PROFESSIONAL ASSOCIATIONS

The American Sociological Association held a binding referendum during the summer to determine whether the 1980 meeting should remain in Atlanta or be moved to an ERA state. A total of 5,286 members voted on the issue. Of these 2,896 or 54.8 per cent voted to move the meeting and 2,390 or 45.2 per cent voted to stay in Atlanta. As a result, the 1980 ASA has been shifted to New York.

The American Political Science Association at its annual business meeting in New York in September voted by a 4 to 1 margin to cancel its contract with the Palmer House in Chicago to convene there in 1979. The meeting overturned a ruling by the chairman that support for ERA violates APSA's constitution which stipulates that the Association will not take stands on questions of public policy except for academic freedom and freedom of expression.

The Business and Professional Women's Foundation announces the Lena Lake Forrest Fellowship Program and the BPW Foundation Research Grant Program

which support research relating to economic, educational, political, social or psychological factors affecting working women. Awards range from \$500 to \$3,000. The Center for Population Research of the National Institutes of Health, HEW, is emphasizing the need for increasing the amount of behavioral-social science research on population, family planning and reproductive behavior. Behavioral-social scientists in disciplines such as economics are invited to submit grant proposals. Attention is also directed toward the postdoctoral fellowship as a mechanism for developing careers in the population field. The deadlines for submission of research grant proposals are March 1, July 1, and November 1, while deadlines for postdoctoral fellowships are February 1, June 1 and October 1.
