

## Appendix – List of Relevant Data Sources

### Data on Conflict Incidence and Fatalities

High quality annual data on conflict incidence, onsets and fatalities is provided by the “UCDP/PRIO Armed Conflict Dataset” and “UCDP Battle-Related Deaths Dataset” which can both be accessed on <https://ucdp.uu.se/> (see UCDP, 2021). An alternative data source at the country-year level is provided by the “Correlates of War (COW) War Data” available on <https://correlatesofwar.org/data-sets> (see Sarkees and Wayman, 2010).

There are also various sources providing disaggregate conflict events data at the precise longitude-latitude and day level. These include “UCDP Georeferenced Event Dataset (GED)” available on <https://ucdp.uu.se/> (see UCDP, 2021), “Armed Conflict Location and Event Data (ACLED)” available on [acleddata.com](https://acleddata.com) (see Raleigh et al., 2010), “Social Conflict Analysis Database (SCAD)” available on <https://www.strausscenter.org/ccaps-research-areas/social-conflict/database/> (see Salehyan et al., 2012), and the “GDELT Project” available on <https://www.gdeltproject.org/> (see Leetaru and Schrodt, 2013).
