DATA AND CODE ARCHIVE AGREEMENT

WHEREAS, the above-named Author has submitted the above-referenced manuscript ("Manuscript") to the American Economic Association ("Association") for consideration for publication; and

WHEREAS, it is the Association's view that the data ("Data") and code ("Code") used in the analysis of the Manuscript should be made available, along with clear and precise documentation ("Documentation");

NOW THEREFORE, in consideration of the opportunity for publication of the Manuscript with Association, Author and Association agree as follows:

1. Author hereby warrants that Author will provide a copy of the Code, Documentation, and all Data that is nonrestricted ("Nonrestricted Data") (collectively, the "Archive") for inclusion in a third-party repository ("Repository") in order to allow for the replication of findings published in the Manuscript and otherwise in order to exercise Association's rights under this Agreement and any agreement between the parties to publish the Manuscript (a "Publication Agreement"). Author agrees to allow the Archive to be shared from the Repository with Association within a reasonable time after delivery to the Repository.
2. If any of the Data is subject to an access restriction beyond the author's control that prevents Author from publishing it ("Restricted Data"), Author shall (i) preserve Data and Code for a period of no less than five years following publication of the Manuscript, (ii) provide reasonable assistance to requests for clarification and replication, (iii) make the Code publicly available, and (iv) publicly document the source of the Data, including appropriate contact information. All instances of Restricted Data must be disclosed at the time of submission of the Manuscript and may be verified by the AEA data editor prior to acceptance of the Manuscript.
3. Author represents and warrants that Author has the right to provide the Archive and that Author has obtained any necessary licenses which include the right of sublicense from any third parties who own any part of the Archive. Author further represents and warrants that Author has complied and will comply with all relevant laws and regulations ("Laws") with respect to the Archive and the Restricted Data, including but not limited to any Laws relating to the use and disclosure of personal, sensitive, or proprietary information.
4. Association has no obligation to publish the Manuscript, but in any case will not publish the Manuscript until it has had the opportunity to review and test the Archive. Association shall provide notice to Author or Author's designee when the Archive has been approved, or not been approved. If the Archive has not been approved, Association will provide information as to the reasons for the non-approval and provide Author with a reasonable opportunity to make corrections.
5. If Association chooses to publish the Manuscript, then upon publication of the Manuscript, Author shall ensure that the Archive shall be made available and will continue to be made available to users in the public ("Users") to replicate the findings published in the Manuscript. Author shall make the Archive available via an open license or licenses ("Open License"), and shall not attempt to terminate the Open License as to any User without express permission from Association. Association prefers the latest version of the Creative Commons Attribution CC-BY for the licensing of Nonrestricted Data, and in any case an Open License that does not impose restrictions other than attribution. Association prefers the Modified BSD license for the licensing of Code.

6. Author shall reimburse Association for any damages, losses, fines, or other costs incurred, including attorney's fees, as a result of a claim by a third party arising from or relating to a breach by Author of any of the representations or warranties provided herein ("Claim") that results in any judgment against Association. Association shall notify Author of any such Claim and shall provide Author with the opportunity to participate in the defense of such Claim, at Author's expense.
7. **Governing Law.** This Agreement is governed by the laws of the State of Tennessee, and by any federal laws which may apply, including but not limited to copyright law. Any dispute between the parties which cannot be resolved by informal means shall be subject to the exclusive jurisdiction of the court of competent authority.
8. **Entire Agreement.** This Agreement, along with the Data and Code Availability Form and the Data and Code Availability Policy, supersedes all other prior discussions and agreements between the parties with respect to the subject matter hereof, written and oral, and constitutes a complete and exclusive statement of the terms of the agreement between the parties and no changes, amendments, or revisions to these terms shall be binding unless expressly confirmed in writing by an authorized representative of each party.
