- 1. Copyright Assignment.** The above-identified author, or his or her employer (“Employer”) if Manuscript is a work-for-hire for the benefit of Employer (“Assignor”), hereby assigns all right, title, and interest in and to the Manuscript, including but not limited to the worldwide copyright(s) therein, and any and all renewals and extensions thereof, and any and all other rights that Assignor now has or to which Assignor may become entitled under existing or subsequently enacted federal, state, or foreign laws. The foregoing notwithstanding, Association hereby acknowledges that for purposes of this Section 1, any data, software, and related software documentation that accompany the Manuscript (“Data and Code”) are excluded from this copyright assignment. Association claims no rights to the Data and Code other than as expressly set forth in this Agreement.
- 2. Other Required Documentation.** Assignor further agrees to execute and deliver all other agreements or documentation reasonably required by Association.
- 3. Reprint Rights.**
  - a. Assignor Reprint Rights.** Association hereby grants to Assignor the right to republication of the Manuscript. Assignor may republish the Manuscript as it is published in the Journal (“Published Version”), in PDF format, in repositories of universities and other institutions with which the Assignor is affiliated at the time of execution of this Agreement or any time thereafter or on the Author’s personal website, provided, however, that Assignor shall include or cause to be included a proper copyright notice (“Copyright Notice”) on any republications. Copyright Notice shall be as follows: *Copyright American Economic Association; reproduced with permission.*
  - b. Third-Party Reprint Rights.** Association grants to Assignor the right to specify the degree of access to which Association grants others the right to reproduce the Published Version (“Reproduction Request”), provided, however, that Association shall have final approval over any Reproduction Request.

### 5. Representations and Warranties.

- a. Assignor warrants that the Manuscript is original work and has not been published previously, in whole or in part. If any material included in the Manuscript (including tables, charts, or figures) is the work of another author or is otherwise under prior copyright protection by another proprietor, Assignor shall obtain or have obtained permission from that copyright proprietor for the inclusion of such material in the Manuscript. Assignor further agrees to save and hold Association harmless in any suit for infringement arising from Assignor's unauthorized use of copyrighted material. Assignor agrees to submit to Association copies of all letters of permission to include copyrighted material of another author included in the Manuscript that is under prior copyright protection by another proprietor.
- b. Assignor further warrants that this Manuscript is not a "work of the United States Government" under 17 U.S.C. § 105 of the United States Code.

**6. ### 7. Miscellaneous.

- a. **Governing Law.** This Agreement is governed by the laws of the State of Tennessee and by any federal laws which may apply, including but not limited to copyright law. Any dispute between the parties which cannot be resolved by informal means shall be subject to the exclusive jurisdiction of the state and federal courts located in Nashville, Tennessee, USA.
- b. **Entire Agreement.** This Agreement, together with the Data and Code Archive Agreement previously executed by Assignor, if any, supersedes all other prior discussions and agreements between the parties, written and oral, and constitutes a complete and exclusive statement of the terms of the agreement between the parties and no changes, amendments, or revisions to these terms shall be binding unless expressly confirmed in writing by an authorized representative of each Party.
